- Wild Wing Golf Memberships include privileges beginning on the date of the contract until formal termination by either party.
- Wild Wing Golf Course reserves the right to revoke or deny any memberships at any time.
- Membership dues and/or playing fees may increase at the discretion of the club.
- Proper golf attire is required.
- Members may book tee times one week in advance. Tee times may be booked in the Golf Shop or by calling (843) 347-9464.
- Current playing fees are \$20 + tax for 18-holes and \$12 + tax for 9-holes. (Restrictions may apply for 9-hole rounds.)
- Members may walk after noon at no charge. Member walking in the morning will be \$12 + tax for 18-holes and \$8 + tax for 9-holes.
- Each member may have up to three accompanied guests play for the "Guest of Member" rate. Guest play may be limited.
- Members who fail to show up for, or properly cancel their tee times are subject to be charged the full value of the starting time.
- Club Membership includes an Honors Club Card and all its privileges. (Does not qualify for purchase gift card.)
- Discontinued Club Memberships may rejoin but will have no priority on the waiting list and must pay the initiation fee again.
- Medical disruptions that result in the inability to use club privileges will be handled by the Founders Group Membership Director. If approved, Club members may be eligible for a 75% reduction of monthly dues for a period of 2 to 6 months with medical documentation.
- Members receive a 20% discount on non-sale soft goods and 10% discount on non-sale hard goods in the Golf Shop.
- Members receive a 20% discount in the grill (excluding alcohol, tobacco, specials events, and daily specials.)

Code of Conduct

- Comply with golf staff, restaurant staff, and maintenance staff requests.
- Abide by all state and local laws and regulations, including the possession of any illegal drugs and weapons on any Founders Group International property.
- Consume alcoholic beverages in a legal and responsible manner, purchasing all alcohol at the facility. Privately-owned coolers are not permitted on the premises

Please note that the privilege of any individual to utilize Founders Group International may be denied, suspended, or terminated if it is determined to be in the best interest of Founders. Any member or visitor who violates or fails to observe the Founders Group International Code of Conduct may be sanctioned as follows:
